Faith Community Homes Helps Families Avoid Crises During Pandemic

The COVID-19 pandemic has hit low-income families hard.

Many families in our program are either still working or receiving unemployment. A few clients have experienced a decrease in hours and, while they are still technically working, their income is lower. Some parents had to stop working because daycare facilities and schools closed and therefore had no one to watch the kids.

Childcare concerns are particularly challenging for single parents. If schools do not physically open for in-person learning in August, many families will be in a dire financial position.

The pandemic has not stopped our volunteer mentors from mentoring their families. In fact, mentoring is more critical now than ever before. Mentors and families are meeting on the phone and online. Household budgets have been adjusted to account for changes in income. Mentors helped families plan for the best uses of their government stimulus money. Due to the rent support and mentoring provided by Faith Community Homes, none of these families has to worry about where they will live next month and all remain current on their bills.

Highlighted below are examples of challenges faced by some of our families during the past few months:



- A single dad's work hours were decreased from 40 to 12 due to COVID-19 in March, April and May. He was also ill for a two-week period with symptoms that mimicked COVID and was unable to work during that time. Without rent support from FCH, he would not have been able to pay rent for three months.
- A single mom is a direct-care provider at a nursing home. Overtime shifts used to be a reliable source of extra income for her, but now she is reluctant to work extra hours for fear of exposing herself and her children to the virus. Her 20-year-old daughter works at the same facility. Mom's 17-year-old daughter just graduated from high school and plans to attend Harper College in the fall.
- A couple's four children required considerable parent participation and supervision during e-learning. Since school ended, the parents have not been able to work available overtime shifts due to childcare constraints. Mom continues her classes in the LPN program at Harper and is due to complete her degree in December.

- A single mom has continued to receive pay checks for her school job during the closure, but no pay for the overtime shifts she began picking up during the past year. Additionally, since summer school is canceled, she does not have the income that she expected at this time.

In many cases, long-term plans – creating a savings account, paying off debt, returning to school – have been put on hold due to the uncertainty of the economy and, more urgently, childcare arrangements. During the second quarter of 2020, Faith Community Homes paid a higher portion of rent for some families based on need and circumstances. It is our priority to help keep all families current on their bills and stabilize their finances.

We are more motivated than ever to help these working parents and their children avoid an unrecoverable financial crisis. We remain committed to keeping a roof over their heads and, just as importantly, to being a source of encouragement and hope for these very vulnerable parents and children.

FCH Perseveres through the COVID Crisis

The pandemic has changed how almost everyone does their work, and Faith Community Homes is no exception. Each day we are finding the inspiration to "make all things new", creatively adapting our services to safely reach those most in need. What has not changed is our focus on FCH families and the adherence to our mission.

Our staff continues to work every day, rotating between in-office and remote locations. FCH has accepted new families into the program during this trying time, especially those in short-term need due to the coronavirus crisis. These families receive some financial assistance as well as case management guidance and support.

Mentoring and case management continues, but generally from a distance using email, conference calls and Zoom. Our priority is to assist families in need while practicing the healthiest and safest ways of doing so. While mentors agree that the process is more challenging when they cannot be together in the same room with families, they are still trying to get the most out of their shorter, less intimate meetings. Having entered into Phase 4 of the recovery, some mentors and families have begun meeting outside or in other “safe” places.

We also want to thank you, the friends of FCH, for your support during this extraordinary time. On May 14, we sent out an eBlast announcing our “Double Your Donation” campaign. We explained that additional funding was needed for three primary purposes:

- To pay additional rent for FCH families who experienced layoffs, reduced work hours, quarantine due to cases at their workplaces, etc.
- To help new families with sudden needs to overcome COVID-related challenges
- To make up for income not realized in our traditional spring events

You responded very generously! With the help of several FCH board members who agreed to double the donation, a total of \$12,604 was raised as a result. A huge thank you for your support!

Save the Date

Due to the pandemic and anticipated restrictions to crowd size, we will be holding Giving Hope, our annual fundraising gala, virtually this year. The tentative date for the event is Sunday, October 11, at 4pm. Event details, including the program and how to access the gala, will be available shortly. We anticipate that the gala will last no longer than one hour.

Annually, Giving Hope is our largest fundraiser of the year with proceeds of \$50,000-75,000. With the local, low-income families that we support facing new challenges during these difficult times, please help us through your active participation in our virtual gala.
